

MEMORANDUM OF UNDERSTANDING

BETWEEN

DESH BHAGAT PANDIT CHETAN DEV GOVT. COLLEGE OF EDUCATION, FARIDKOT

AND

MAHATMA GANDHI MEMORIAL SENIOR SECONDARY SCHOOL, FARIDKOT

WHEREAS, the Parties have decided to undergo the exchange of Pupil Teachers for internship and research;

WHEREAS, the MOU shall be effective from 03-03-2023;

NOW, THEREFORE, this Memorandum of Understanding (MOU) sets the following terms and understanding between the Desh Bhagat Pandit Chetan Dev Govt. College of Education, Faridkot (GCE, Faridkot) and the Mahatma Gandhi Memorial Senior Secondary School, Faridkot (MGM School, Faridkot) for internship and research projects undertaken by pupil teachers of GCE, Faridkot in MGM School, Faridkot

- **Background:** GCE, Faridkot is being run by Department of Higher Education, Government of Punjab and this institute provide Bachelor of Education (B.Ed.) & Master of Education (M.Ed.) Programs along with other short-term courses in field of Education. Students of these courses are required to undergo a compulsory internship and research projects during their training as a Pupil Teacher.
- **Purpose:** Purpose of this MOU is to ensure good infrastructure and environment for training of Pupil Teachers. Some Pupil Teachers will be sent to MGM School, Faridkot for Three months of internship (Number of students may vary). During Internship/training period pupil teachers of GCE, Faridkot will teach full time in the MGM School Faridkot and will help the MGM School, Faridkot in organizing other extracurricular activities. This will benefit pupil teachers as well as MGM School, Faridkot. Some Students will also be sent for doing their research in field of education (topics may vary) MGM Faridkot will provide their support to the students in undertaking their research projects.
- **Terms of MOU:** This MOU is effective upon the day and date last signed and duly authorized by the authorized representatives of the parties and governing bodies of the parties. This MOU shall remain in full force and effect for next five years, this MOU shall be terminated, without cause, by either party upon Two Months written notice, whereas the notice shall be delivered by hand or by certified mail.
- **Reporting:** Heads of both institutes will evaluate effectiveness and adherence to the agreement.
- **Payment Terms:** No payment will be given for sending pupil teachers to School and no payment will be demanded for services being provided by pupil teachers.

- **Duration:** This MOU shall become effective upon signature by the authorized representative of the parties and will remain in effect until modified or terminated by mutual consent.
- **Confidentiality:** The parties acknowledge that information disclosed by one party to the other (the disclosing party) in the course of the subject matter of this MOU may be confidential and unless required by law must not be disclosed to a third party except with the prior written consent of the disclosing party.
- **Dispute resolution:** Any dispute if arises shall be resolved by discussion between heads of both institutes.

NOW WHEREAS, the effective date of this MOU is date of the signature last affixed by the parties.
